A Show Cause Notice (SCN) dated 15.07.2023 was issued by the SRC, NCTE w.r.t deficiency pointed out by the TamilNadu Teachers Education University (TNTEU), Chennai. The institution submitted reply to SCN vide letter dated 22.08.2023 and the matter was placed before 429th meeting of SRC held on 11th October, 2023 and SRC decided as follows:-

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The reply submitted by the institution dated 24.08.2023 with reference to the SCN dated 15.07.2023 w.r.t deficiencies pointed out by the TNTEU, Chennai,

the Committee observed that the institution submitted documents as per provision of the NCTE Regulations, 2014 and found the same satisfactory.

Hence the Committee decided that status-quo of the institution be maintained and recognition granted to B.Ed., M.Ed. is hereby continued".

In view of the above, the decision of the SRC is communicated to all the concerned for information and necessary action.
