ORDER:

In his letter seventh read above, the Managing Trustee, Bharath Educational Trust, Thiruvarur District has requested the Government for

granting permission to start four years B.Sc (Nursing) course at "Bharath College of Nursing", Thiruvarur District.

- 2. In the Government letter eighth read above, the Director of Medical Education and Research was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education and Research has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to sixth read above and as per the norms of the Indian Nursing Council, New Delhi.
- 3. In her letter ninth read above, the Director of Medical Education and Research has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi and recommended to grant permission to Bharath Educational Trust, Thiruvarur District to start four years B.Sc (Nursing) course at "Bharath College of Nursing", Thiruvarur District with 60 seats.
- 4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and Research and decided to accept the same. Accordingly, the Government hereby grant No Objection Certificate to the Managing Trustee, Bharath Educational Trust, Thiruvarur District for starting B.Sc (Nursing) course at "Bharath College of Nursing in Survey No. 178/5, 178/6, 183/35, 183/47 at Ammaiyappan Village, Thiruvarur District and lease building for hostel in TS.No.748, Door. No.102-1, Durgalaya Road, Thiruvarur Taluk and District with 60 (sixty) seats from the academic year 2023-2024, subject to fulfillment of the general conditions laid down in G.O(Ms)No.219, Health and Family Welfare (PME-2) Department, dated: 06.06.2018 and G.O(Ms)No.269, Health and Family Welfare (PME-2) Department, dated:18.7.2020 as applicable to this proposal before admitting the students.

"The Trust should obtain recognition/affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. MGR Medical University and if needed, suitability from Indian Nursing Council, New Delhi".

5. The Director of Medical Education and Research is directed to take necessary further action accordingly.
