This has reference to your proposal which has been submitted by your
institution to start B.Sc.,(N) programme for the academic year 2023-2024. Your
institution was inspected on 29.07.2023. After going through the report, comments of
the inspectors, documents and compliance report submitted by the institution
(vide. Ref.No: 3 to 5), we are herewith communicating the following order for
information and necessary action.

ORDER:

The Tamil Nadu Nurses and Midwives Council having noted the clearance given by the Tamil Nadu Government for 60 students for starting a College of Nursing for Degree programme in B.Sc., Nursing programme at **Bharath College of Nursing, Thiruvavur** and having satisfied itself with the infrastructure available in the institution as pointed out in the Primary/Statutory inspection report and in exercise of the powers vested with the Council under rule 37 of the rules made under Section 11(2) (c) of the Tamil Nadu Nurses and Midwives Act (Tamil Nadu Act III) 1926 resolves to Grant Provisional Recognition to the above said institution to conduct the first year **B.Sc., Nursing Programme for the academic year 2023-2024** only with an annual intake of not exceeding 50 Students based on the Parent Hospital "Arun Medical Centre, North Main Street, Tiruvavur" shown by the institution as well as Certificate of Registration of Clinical Establishment issued for "Arun Medical Centre, North Main Street, Tiruvavur" with 112 beds subject to the following conditions:

1. Do not admit underage & overage students.
2. Admission of candidates should not exceed the number indicated in Tamil Nadu Nurses and Midwives Council Order for the year 2023-2024 and admission must be made only once a year.
3. Fresh batch of admission of students is permitted for 2023-2024 academic year only.
4. Every year list of candidates admitted during the year together with their age and qualification to be uploaded in the Council's **Institution Management System (I.M.S.)** for the purpose of registration. Also should come to the Council for certificate verification as and when informed by this Council.

5. The institution should not charge any capitation fee or donation for admission of candidates except the regular tuition and special fees as laid down in the prospectus/regulations.
 6. **The institution should obtain Affiliation Order from the TN.Dr.M.G.R Medical University for the academic year 2023-2024 before admitting the students and should submit the copy of the same to this Council.**
 7. **As specified in the Government Order the other general conditions laid down in G.O.(Ms) No.219, Health and Family Welfare (PME2) Department, dated: 06.06.2018 and G.O(Ms)No.269, Health and Family Welfare (PME2) Department, dated:18.07.2020 as applicable to this proposal before admitting the students for the above said course as mentioned in the G.O.(Ms) No.210 Health and Family Welfare (PME.2) Department dated: 30.06.2023.**
 8. For a nursing institution (managed by Trust) a “**Parent Hospital**” would be a hospital either owned and controlled by the trust or managed and controlled by a member of the trust. In case the owner of the hospital is a member of the trust that the hospital would continue to function as a “**Parent Hospital**” till the life of the nursing institution. **If not, Provisional Recognition will be withdrawn.**
 9. **The institution should submit copy of the following documents for the academic year 2023-2024 at the earliest.**
 - a. **Government order for tie-up with Government Women and Children Hospital, Vijayapuram, Tiruvarur or Government Hospital, Kootanallur.**
 - b. **Government order for tie-up with Rural PHC Kulikkarai & Urban PHC.**
- NOTE: If not the following academic year admission shall be withheld.**
10. Failure to maintain the prescribed requirements will result in de-recognition.
 11. The Council is entitled for surprise inspection without any prior notice. If the institution is found unsuitable, the recognition will stand cancelled and thereupon the Council shall not be responsible for the students admitted by the institution.

12. Inspection will be arranged by this Council before starting II-batch of programme in **2024-2025** under Rule (38) of the rules framed under section 11 (2) (c) of the Tamil Nadu Nurses and Midwives Act III of 1926 and **students should be admitted for II year after obtaining orders from the Council only.**
13. The institution shall have to abide by the guidelines/instructions/regulations issued by Tamil Nadu Nurses and Midwives Council, State Government/ Indian Nursing Council, New Delhi from time to time.
14. The institution shall have to abide by the guidelines/instructions/regulations issued by Indian Nursing Council, New Delhi with regard to availability of Teaching faculty, Clinical and Physical Facilities, Infrastructural facilities in conformity with Regulations framed under the provisions of Indian Nursing Council Act 1947.
15. **Annual Programme processing fee of B.Sc.,(N) must be paid by 30th June every year through online mode in Council website under the link "INSTITUTION MANAGEMENT SYSTEM (IMS)".**
16. **Council Prescribed Uniform should be adoned by the students and it should be strictly adhered (Copy enclosed).**
17. All the correspondence should be done by the Principal only.
18. Check Council's website: **www.tamilnadunursingcouncil.com** frequently for updates.
